Authorization to award the Pebble Creek Bank Stabilization Project Contract to DelMae, LLC in the amount of \$83,300. The Pebble Creek Stabilization Project along the North Bank of the Section of Wilson Downing Tributary behind the properties of 612, 616, and 628 Pebble Creek Drive has approximately 250 linear feet of stream bank that is eroding from recent utility work in the area. This project will restore the bank to conditions prior to construction. Funds are Budgeted. (L0471-24) (Martin/Albright)
