An Ordinance amending the authorized strength by abolishing one (1) vacant classified position of Operations Supervisor, Grade 518E, and one (1) vacant classified position of Safety Coordinator, Grade 516N, and creating one (1) classified position of Equipment Operator, Grade 510N, and one (1) classified position of Safety Specialist, Grade 518N, in the Div. of Streets and Roads, effective upon passage of Council. [Div. of Human Resources, Maxwell]

Authorization to abolish one (1) vacant classified position of Operations Supervisor (Grade 518E), one (1) vacant classified position of Safety Coordinator (Grade 516N) and create one (1) classified position of Equipment Operator (Grade 510N), one (1) classified position of Safety Specialist (Grade 518N) in the Division of Streets and Roads, effective upon passage of Council. Upon the request of the div., and in accordance with the Code of Ordinances, the Division of Human Resources conducted classification studies on the requested positions. The positions were analyzed by staff using the whole job rank and factor comparison methods. As a result, a recommendation for their requested positions is described in this action. This will have a future impact of a savings of \$15,102.48. (L0187-21) (Maxwell/Hamilton)
