WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$122,100 to provide funds for Council Capital projects in the Divisions of Traffic Engineering and Parks and Recreation:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount \$122,100 to provide funds for Council Capital projects in the Divisions of Traffic Engineering and Parks and Recreation that to effect such Amendments the following appropriations be and hereby are authorized and directed:
