Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute Change Order No. 2, which is attached hereto and incorporated herein by reference, to the Agreement with Lagco, Inc., for construction of the Meadows/Northland/Arlington Public Improvements Project, Phase 6B1 and 6B2, increasing the Contract price by the sum of \$147,110.64, raising the total price to \$2,772.879.64.

Section 2 - That an amount, not to exceed the sum of \$147,110.64, be and hereby is approved for payment to Lagco, Inc., from account # 3120-303202-91713 (\$113,277.64) and account # 4003-303202-91715 (\$33,833.00), pursuant to the terms of the Change Order and the Agreement.
