Authorization to execute a sole source agreement with HACH Company for the purchase of chemical kits required for use by the HACH DR5000 Spectrophotometer in the Division of Sanitary Sewers. HACH Company is the sole manufacture of these products which are created specifically for use with the HACH Spectrophotometer located in the laboratory house at the Town Branch Wastewater Treatment Plant, and used daily to test water quality measurements. The cost for fiscal year 2016 will be \$25,578.96. Funds are budgeted. (L1111-15)(Martin/Holmes)
