Section 2 - That an amount not to exceed the sum of \$1,542,300.00 be and hereby is approved for payment to Commerce Lexington (\$457,000.00 from account #1101-900101-0001-71101), the Downtown Lexington Corporation (\$42,710.00 from account #1101-900103-0001-71101),

Downtown Development Authority (\$324,540.00 from account 1101-900609-0001-82101), World Trade Center Kentucky (\$72,000.00 from account 1101-900104-0001-71101), SCORE (\$7,000.00 from account #1101-900105-001-71101), Lyric Theatre (\$150,000.00 from account #1101-900107-0001-71101), and LexArts (\$489,050.00 from account #1101-900109-0001-71101) pursuant to the terms of the respective Purchase of Service Agreements.
