Section 2 - That an amount, not to exceed the sum of \$110,233.94, be and hereby is approved for payment to Everbridge, Inc., from account #3200-505201-0001-76102 (\$40,000.00), account # 3200-505204-5291-76102 (\$22,343.94), account #1101-505204-5242-76102 (\$31,540.00), and account #4204-505602-5622-76102 (\$16,350.00), pursuant to the terms of the Agreement.
