WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for the Division of Parks and Recreation for funds in the amount of \$282.00 from Neighborhood Development Funds for improvements to Douglass Park scoreboards:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for the Division of Parks and Recreation for funds in the amount of \$282.00 from Neighborhood Development Funds for improvements for Douglass Park scoreboards and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in Schedule No. 0022, attached hereto and incorporated herein by reference.
