Authorization to abolish one (1) unclassified position of Affordable Housing Manager (Grade 526E) and create one (1) unclassified position of Affordable Housing Manager P/T (Grade 526N) and reallocate the incumbent in the Commissioner’s Office of Planning, Preservation & Development, effective January 8, 2018. With the position being part-time this has a 12-month future impact savings of \$62,589.95. (L1276-17) (Maxwell/Hamilton)
