## **GOVERNMENT:**

Section 1 - That for the purposes of support of the Soil and Water Conservation District and the payment of its debts and expenses for the Fiscal Year July 1, 2020 through June 30, 2021, there be and hereby is levied an ad valorem tax on each One Hundred Dollars (\$100.00) of the assessed valuation of all taxable real property, including real property of public service companies, within the File #: 0863-20, Version: 1

taxing jurisdiction of the Lexington-Fayette Urban County Government as of the January 1, 2020 assessment date, in the amount of \$.0006.
