(SLX)), \$13,500.00 (Air Quality Planning (SLX)), \$16,800.00 (Congestion Management (SLX)) and

\$13,200.00 (Bike/Ped Planning (SLX)) as a local match, subject to sufficient funds being

appropriated in FY 2016. Further, all statements, representations, warranties, covenants, and

agreements contained in the Agreement are hereby ratified and adopted and the funds provided in

the Agreement are hereby accepted and by such acceptance the Urban County Council agrees to all

the terms and conditions stated therein.

Section 2 - That subject to the provisions of Ordinance No. 22-79, the Mayor is hereby

authorized, in his discretion as Chief Executive Officer of the Urban County Government, to transfer

the unencumbered balance of any operating or capital account appropriation to another operating or

capital account appropriation within the Grant budget established herein.

Section 3 - That this Resolution shall become effective on the date of its passage.
