Authorization to establish Harp Enterprises Inc. as a sole vendor for the purpose of purchasing Hart InterCivic’s Hart Voting System (HVS) machines used in Fayette County elections. Harp Enterprises Inc. is the only authorized reseller in Kentucky. Machines will be purchased over the next two Budget years at a cost of \$105,600 in FY 16 and FY17 \$369,600. Funds are Budgeted.
