Section 2 - That an amount, not to exceed the total sum of \$204,016.00, inclusive of an administrative fee not to exceed \$20,401.60, be and hereby is approved for payment to the Catholic Charities of the Diocese of Lexington from account # 155003-0001-78112, pursuant to the terms of the Purchase of Services Agreement.
