Authorization to execute a Consent to Assumption Agreement for Granicus LLC to assume all rights, duties, benefits, and obligations from Vision Technology Solutions LLC under our previous Agreement, dated 6/25/2015, for maintenance and support of visionLive, on-premise subscription services for the Intranet. BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute the Consent to Assumption Agreement, which is attached hereto and incorporated herein by reference, with Granicus, LLC, authorizing Granicus to assume the rights, duties, benefits, and obligations of Vision Technology Solutions, LLC, in its contract with the Urban County Government for intranet services.

Section 2 - That an amount not to exceed the sum of \$8,599.50.00 in fiscal year 2021, and increasing by 5% annually thereafter, be and hereby is approved for payment to Granicus, LLC, from account #1101-202505-0001-76102 per year, pursuant to the terms of the Consent to Assumption Agreement.

Section 3 - That this Resolution shall become effective on the date of its passage.
