An Ordinance amending the Classified Civil Service authorized strength by abolishing one (1) Vacant Position of Skilled Trades Worker Sr., Grade 517N, and creating one (1) Position of Corrections Building Maintenance Sr., Grade 519N, changing the position title of one (1) Vacant Position of Corrections Maintenance Mechanic Sr., Grade 519N, to Corrections Building Maintenance Sr., Grade 519N, all in the Div. of Community Corrections, effective upon passage of Council. [Div. of Human Resources, Maxwell]

Authorization to abolish one (1) vacant classified position of Skilled Trades Worker Sr. (Grade 517N) and create one (1) classified position of Corrections Building Maintenance Sr. (Grade 519N). In addition, the attached action is also requesting authorization to change the title of one (1) vacant position of Corrections Maintenance Mechanic Sr. (Grade 519N) to Corrections Building Maintenance Sr. (Grade 519N) all in the Division of Community Corrections, effective upon passage of Council.

Upon the request of the div. and in accordance with the Code of Ordinances, the Division of Human Resources conducted classification studies according to standard procedures using the Job Analysis Questionnaire and position audit. The fiscal impact for FY 2016 will be a cost of \$2,184.52. Funds are Budgeted. (L146-16) (Maxwell/Hamilton)
