Upon the request of the div., the Division of Human Resources conducted a reclassification study on the requested position of Eligibility Counselor held by John Walker within the Division of Youth Services. As a result, a recommendation for the reclassification is described in this action. There will be no change in his salary and this will not have a 12-month future impact cost.
