An Ordinance amending the authorized strength by abolishing one (1) Unclassified Civil Service Position of Eligibility Counselor, Grade 513E, and creating one (1) Unclassified Civil Service Position of Life Skills Program Instructor, Grade 512N, and reclassifying the incumbent in the Div. of Youth Services, effective upon passage of Council. Authorization to abolish one (1) unclassified position of Eligibility Counselor (Grade 513E) and create one (1) unclassified position of Life Skills Program Instructor (Grade 512N); reclassifying the incumbent within the Division of Youth Services, effective upon passage of Council. Upon the request of the div., the Division of Human Resources conducted a reclassification study on the requested position of Eligibility Counselor held by John Walker within the Division of Youth Services. As a result, a recommendation for the reclassification is described in this action. There will be no change in his salary and this will not have a 12-month future impact cost. Section 1 - That subsection line number 650.050 in the unclassified civil service authorized strength be and hereby is deleted.

Section 2 - That the following subsection line number in the unclassified civil service authorized strength be and hereby is created to read as follows:

650.060 1 994 512N Life Skills Program Instructor

Section 3 - That the incumbent, John Walker, be and hereby is reclassified from Eligibility Counselor, Grade 513E, at \$1,782.96 biweekly to Life Skills Program Instructor, Grade 512N, at \$22.287 hourly.

Section 4 - That this Ordinance shall become effective on passage of Council.
