Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute the Purchase of Service Agreement, which is attached hereto and incorporated herein by reference, with LexArts, Inc., for various services relating to providing support to the arts community and community at-large, at a cost not to exceed \$325,000.00.

for payment to LexArts, Inc. from account #1101-900109-71101, pursuant to the terms of the Agreement.
