WHEREAS, pursuant to House Bill 26, enacted by the 2019 Kentucky General assembly, the Lexington-Fayette Urban County Government May increase the amount of an expenditure for which it is not required to legally advertise for bids from \$20,000 to \$30,000; and

WHEREAS, the Lexington-Fayette Urban County Government would like to raise the amount of its bids that would require legal advertisement from \$20,000 to \$30,000 and make other changes to its Procurement Regulations consistent with HB 26.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Lexington-Fayette Urban County Government hereby amends the attached "Lexington-Fayette Urban County Government Procurement Regulations" to increase the amount of and expenditure for which the Lexington-Fayette Urban County Government is not required to legally advertise for bids from \$20,000 to \$30,000, and make other changes consistent with HB 26, enacted by the 2019 Kentucky General Assembly.

Section 2 - That the Lexington-Fayette Urban County Government hereby approves, adopts, and restates the "Lexington-Fayette Urban County Government Procurement Regulations" (29 pages), which are attached hereto and incorporated herein by reference as if fully stated, to govern all procurement activities of the Lexington-Fayette Urban County Government.

Section 3 - That the regulations as amended, approved, adopted and restated herein shall become effective on July 1, 2019.
