BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That Section 2-507 (b) of the Code of Ordinances, Lexington-Fayette Urban County Government, be and hereby is amended to read as follows:

Sec. 2-507 Membership.

(b) The nineteen (19) members shall be comprised as follows:

- (1) Three (3) ex-officio members shall be from the Lexington-Fayette Urban County Council;
- (2) One (1) member shall be a veteran of the United States Army;
- (3) One (1) member shall be a veteran of the United States Navy;
- (4) One (1) member shall be a veteran of the United States Air Force;
- (5) One (1) member shall be a veteran of the United States Coast Guard;
- (6) One (1) member shall be a veteran of the United States Marine Corps;
- (7) One (1) member shall be a veteran and a member of the Disabled American Veterans Organization;
- (8) Five (5) members shall be affiliated with Veterans Service Organizations;
- (9) One (1) ex-officio member shall be the Commissioner of the Lexington-Fayette Department of Public Safety, or his/her designee;
- (10) One (1) ex-officio member shall be the Chief Administrative Officer of the Lexington-Fayette Urban County Government, or his/her designee;
- (11) One (1) member shall be an inductee to the Kentucky Veterans Hall of Fame;

(12) Two (2) members shall be from the Lexington-Fayette County community-at-large.

Section 2 - That this Ordinance shall become effective on the date of its passage.
