NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

**URBAN COUNTY GOVERNMENT:** 

Section 1 - That the Zoning Ordinance of the Lexington-Fayette Urban County Government

be amended to show a change in zone for property located at 2380 Fortune Drive from a Light

Industrial (I-1) zone to a Wholesale & Warehouse Business (B-4) zone, for 0.032 net (0.085 gross)

acre; and from a Planned Shopping Center (B-6P) zone to a Wholesale & Warehouse Business (B-4)

zone, for 2.18 net (2.79 gross) acres, being more fully described in Exhibit "A" which is attached

hereto and incorporated herein by reference.

Section 2 - That the Lexington-Fayette Urban County Planning Commission is directed to

show the amendment on the official zone map atlas and to make reference to the number of this

Ordinance.

Section 3 - That this Ordinance shall become effective on the date of its passage.
