Section 2 - That an amount, not to exceed the sum of \$46,732.00, be and hereby is approved for payment to 911 Datamaster LLC, \$32,550.00 from account #4205-505602-76102, \$10,182.00 from account #4204-505602-76102 and \$4,000.00 from account #4204-505603-76102
