Authorization to execute a ten (10) year, forgivable incentive Agreement with Consolo Services Group for the creation of thirty (30) new jobs at an average wage of \$26.88 per hour. The incentive Agreement will be for \$100,000. The Economic Development Investment Board received a Jobs Fund Incentive application from Consolo Services Group for incentives to support the wages for thirty new (30) jobs. BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:
