Authorization for the Mayor to execute the FY2016 Purchase of Service Agreement and Addendums A and B with the Bluegrass Area Development District for State Homecare Match funds at a cost of \$48,610. LFUCG's contribution towards required State Homecare Grant fund match supports Bluegrass ADD's operation for the Homecare Program for home-bound seniors. The Homecare Program provides in-home assistance for Fayette County seniors who are low income. This allows our Fayette County Seniors to stay in their homes as long as possible versus skilled or long term care facilities. Funds are budgeted. (L1199-15)(Ford)
