Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute the Facility Usage Contract, which is attached hereto and incorporated herein by reference, with the Fayette County Board of Education to allow the Division of Parks and Recreation to use certain school facilities for its extended school program and recreational enrichment and learning program for the 2015-2016 school year.
