BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 2 - The plaque will be installed in the sidewalk at 141 East Main Street. Upon approved installation, ownership of the plaque shall transfer from the Downtown Lexington Management District to Lexington-Fayette Urban County Government. The Downtown Lexington Management District shall Grant, convey, and transfer all such rights and obligations, including but not limited to providing insurance coverage and maintenance of the plaque.

Section 3 - That this Resolution shall become effective on the date of its passage.
