BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Council of Lexington-Fayette Urban County Government does hereby approve and adopt a substantial amendment to the 2017 Annual Action Plan, which are attached hereto and incorporated herein by reference, decreasing funds for the Community Action Council Youth 180 Program (\$10,000.00), reallocating those funds to the Realtor Community Housing Foundation RAMP Program (\$10,000.00).
