A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute an Agreement with Pictometry International, Corp., a sole source provider, for the lease of oblique aerial photography and imaging software, required licenses, hosting services, and supporting maintenance, for up to six years, subject to sufficient funds being appropriated in future fiscal years, at a cost not to exceed \$63,969.50 in FY 2016. Authorization to establish a sole source provider contract with Pictometry International for the lease of oblique aerial photography, viewing software, hosting services, traditional aerial photography, and supporting maintenance for three flight deliverables (2016, 2018 and 2020) funded over a six-year period. BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute an Agreement, which is attached hereto and incorporated herein by reference, with Pictometry International, Corp., for the lease of oblique aerial photography and imaging software, required licenses, hosting services, and supporting maintenance, for up to six years, subject to sufficient funds being appropriated in future fiscal years.

Section 2 - That an amount, not to exceed the sum of \$63,969.50, be and hereby is approved for payment to Pictometry International, Corp. in FY 2016, from account #4204-505603-71299, pursuant to the terms of the Agreement.

Section 3 - That this Resolution shall become effective on the date of its passage.
