Authorization to execute an Amendment to the Agreement regarding a radio tower lease for the Public Safety radio system. The WVRB radio tower site is under new ownership, therefore, Educational Media Foundation (EMF) is now listed as the property owner/landlord of the property with whom LFUCG leases space. The annual lease cost of \$21,920.16 persists from the legacy Agreement, with an annual CPI increase of 3% going into effect in May 2023. Funds are Budgeted. (L0220-23) (Patten/Armstrong)
