WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

-) \$ 1,000,000.00 _ _from_ the Unappropriated Fund Balance in the General Services District Fund _to_ various accounts.
-) \$ 314,600.00 _ _from_ the Unappropriated Fund Balance in the Full Urban Services District Fund _to_ various accounts.
-) \$ 680,000.00 _ _to_ the Unappropriated Fund Balance in the Refunding GO Bond 2015A _from_ various accounts.
-) Re-appropriations within the General Services District Fund; Donation Fund; General Fund Capital Projects; Full Urban

Services District Fund; Police Confiscated State Fund; Refunding GO Bond 2015A; Water Quality Construction Fund; Police and

Fire Retirement; and the various grant funds which do not result in changes to the Unappropriated Fund Balance of these funds.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0074" attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
WHEREAS, it is necessary and proper to amend the budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$1,000,000.00 from the Unappropriated Fund Balance in the General Services District Fund to various accounts.

) \$314,600.00 from the Unappropriated Fund Balance in the Full Urban Services District Fund to various accounts.

) \$680,000.0 to the Unappropriated Fund Balance in the Refunding GO Bond 2015A from various accounts.

) Re-appropriations within the General Services District Fund; Donation Fund; General Fund Capital Projects; Full Urban Services District Fund; Police Confiscated State Fund; Refunding GO Bond 2015A; Water Quality Construction Fund; Police and Fire Retirement; and the various grant funds which do not result in changes to the Unappropriated Fund Balance of these funds.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0074" attached hereto and incorporated herein by reference.
