Authorization to establish a Standard Software Maintenance Agreement between New World Systems Corporation (New World) and Lexington-Fayette Urban County Government. This agreement provides standard software maintenance support services provided by New World, upgrades and revision to the software application package. The attached agreement requires the Mayor's signature. This agreement shall remain in effect for a period of three (3) years, from July 1, 2015 through June 30, 2018. The annual cost will be \$134,760. This maintenance agreement is fully budgeted for fiscal year 2016. (L1429-15)(Barnard/Bastin)
