WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government for Council appropriations for various projects from American Rescue Plan act (ARPA) State and Local Recovery Funds, as approved February 17, 2022:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:
