BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute Change Order No. 13, which is attached hereto and incorporated herein by reference, to the contract with Churchill McGee, LLC, for the Public Safety Operations Center Renovation Project-Phase 1B, increasing the contract price by the sum of \$29,099.31 from \$6,620,561.93 to \$6,649,661.24.

Section 2 - That an amount, not to exceed the sum \$29,099.31, be and hereby is approved for

payment to Bluegrass Contracting Corporation from accounts #3200-505201-0001-91017 and #1115-160302-0001-91017 pursuant to the terms of the Change Order.
