WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$5,000.00 to provide funds for Council Projects in the Division of Traffic Engineering for the purchase and installation of speed tables for Glendover Road:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount of \$5,000.00 to provide funds for Council Projects in the Division of Traffic Engineering for the purchase and installation of speed tables for Glendover Road that to effect such Amendments the following appropriations be and hereby are authorized and directed:
