WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$_167,000.00__from__ Full Urban Services District Fund _to_ various accounts.

) \$_225,000.00__from__ Police Confiscated Federal Fund _to_ various accounts.

) \$_400,000.00__from__ Sanitary Sewer Construction Fund _to_ various accounts.

) \$_1,141.26__from__ PFC - Parks Projects Fund _to_ various accounts.

) \$ 200,000.00 from Landfill Fund to various accounts.

) \$ 42,613.67 to Extended School Program Fund from various accounts.

) Re-appropriations within the General Services District Fund; Police Confiscated Federal Fund; Lexington Economic Development Fund; Sanitary Sewer Revenue and Operating Fund; Water Quality Management Fund; and various Grant funds that do not result in changes to the Unappropriated Fund Balance of these funds.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0019" attached hereto and incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.

WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$167,000.00 from Full Urban Services District Fund to various accounts.

) \$225,000.00 from Police Confiscated Federal Fund to various accounts.

) \$400,000.00 from Sanitary Sewer Construction Fund to various accounts.

) \$1,141.26 from PFC - Parks Projects Fund to various accounts.

) \$200,000.00 from Landfill Fund to various accounts.

) \$42,613.67 to Extended School Program Fund from various accounts.

) Re-appropriations within the General Services District Fund; Police Confiscated Federal Fund; Lexington Economic Development Fund; Sanitary Sewer Revenue and Operating Fund; Water Quality Management Fund; and various Grant funds that do not result in changes to the Unappropriated Fund Balance of these funds.

Section 2 - That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in "BUDGET SCHEDULE NO. 0019" attached hereto and

incorporated herein by reference.

Section 3 - That this Ordinance shall become effective on the date of its passage.
