NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

**URBAN COUNTY GOVERNMENT:** 

Section 1 - That the Zoning Ordinance of the Lexington-Fayette Urban County Government

be amended to show a change in zone for property located at 2679 Leestown Road from a Highway

Service Business (B-3) zone to a High Density Apartment (R-4), for 8.163 net (8.727 gross) acres,

and from a Professional Office (P-1) zone to a High Density Apartment (R-4) zone, for 0.027 net

(1.352 gross) acres, being more fully described in Exhibit "A" which is attached hereto and

incorporated herein by reference.

Section 2 - That the Lexington-Fayette Urban County Planning Commission is directed to

show the amendment on the official zone map atlas and to make reference to the number of this

Ordinance.

Section 3 - That this Ordinance shall become effective on the date of its passage.
