Authorization to execute a Memorandum of Understanding between the Family Care Center and Planned Parenthood of Indiana and Kentucky. In partnership with Fayette County Schools, the Family Care Center operates a Parent Education Program for parenting and expectant teen moms. This MOU will provide parental education designed to reduce repeat pregnancy rates among Family Care Center students. 45 FCC students will be provided ten hours of age-appropriate, medically accurate, comprehensive education taught by professional educational facilitators.
