BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute an agreement with I/O Solutions, Inc., which is attached hereto and incorporated herein by reference, for police sergeants and police lieutenants promotional processes for the Lexington Division of Police, at a cost not to exceed \$76,000.00
