Authorization to execute a service agreement with Windstream Communications to establish a telephone fiber circuit connection in Lexington's new 911 Center located in the Public Safety Operating Center (PSOC). The cost in FY16 is estimated to be \$10,520.75, depending on the PSOC construction schedule, and \$25,500 annually in subsequent budget years. Funds are budgeted for fiscal year 2016.
