Authorization to execute Change Order No. 2 (Final) in the amount of \$50,228.96 to the contract with Bluegrass Contracting Corporation for the Tates Creek Road Sidewalk Improvements Project. The new contract amount is \$1,759,676.87. This project provides for the construction of sidewalks on both sides of the road from Enclave to Dove Run Road.
