A Resolution authorizing the Mayor, on behalf of the Urban County Government, to execute a First Amendment to Lease Agreement with NAMI Lexington (KY), Inc., extending the term of its lease by one year. [Dept. of General Services, Reed]

Authorization to amend Lease Agreement (R 269-2012); Contract (#167-2012) between the LFUCG and NAMI Lexington (KY), Inc. for approximately 813 S/ft of rentable space within the Black & Williams Neighborhood Center located at 498 Georgetown Street in Lexington. The amendment allows for continued occupancy at the same terms and conditions for one (1) additional year during which time a new facility usage plan promoting occupant activity to serve community-based need is created. The amendment provides that all other terms & conditions of the agreement shall remain the same; becomes effective on July 1, 2015, and expires on June 30, 2016. The revenue from the lease will be \$3,767.96 in FY 16. (L0721-15)(Reed)
