A Resolution authorizing the Mayor, on behalf of the Urban County Government, to execute a Letter of Intent to sell .237 acres of land, two permanent guying easements, and one temporary construction easement to Ky. Utilities Co. [Dept. of General Services, Reed] Authorization to execute a Letter of Intent (LOI) and any other documents necessary for Kentucky Utilities Company (KU) to purchase land, acquire two permanent guying easements, and to be granted one temporary construction easement. The action is needed to enable upgrades to KU transmission and substation facilities that will increase capacity and better serve their customers.

Investigation has revealed that the sale of the land is not detrimental to the park and if approved, KU shall pay fair market value for the property. There is no expenditure by LFUCG. Revenue is to be determined by appraisal. (L1139-15)(Reed)
