Section 2 - That an amount, not to exceed the sum of \$19,500.00 (FY2015), be and hereby is approved for payment to OpenGov, Inc., from account #1101-202201-71202 (\$15,000.00) and account #1101-202101-71202 (\$4,500.00), with any renewals to be exercised by the Department of Finance and contingent upon sufficient funds being appropriated.
