Section 1 - That the Division of Traffic Engineering is authorized and directed to install three (3) speed tables on Bob o Link Drive between Harrodsburg Road and Saint Joseph Drive per guidelines in the Neighborhood Traffic Management Program.

Section 2 - That an amount not to exceed \$13,500.00 is approved for the installation of three (3) speed tables on Bob o Link Drive between Harrodsburg Road and Saint Joseph Drive, from account 1105-303602-91614.
