BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 2 - That estimated amounts not to exceed the following sums stated be and hereby are approved for payment to each of the following entities contingent upon the approval of any necessary Budget amendments and pursuant and subject to the terms of the respective Agreements: (a) \$2,000,000.00 to Bluegrass Community and Technical College from account # 3230-900115-71101; (b) \$1,000,000.00 to Lexington Public Library from account # 3230-900605-71101; (c) \$78,000.00 to Lexington Community Radio, Inc. d/b/a RadioLEX from account # 3230-900377-71101; (d) \$400,000.00 to Greenhouse17, Inc., from account # 3230-900304-71101; (e) \$991,000.00 to Commerce Lexington, Inc., from account # 3230-900101-1101; (f) \$350,000.00 to Lexington Rescue Mission, Inc., from account # 3230-900250-71101; and (g) \$170,000.00 to NAMI Lexington (Ky), Inc., from account # 3230-900349-1101 (FY23).
