NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE

**URBAN COUNTY GOVERNMENT:** 

Section 1 - That the Zoning Ordinance of the Lexington-Fayette Urban County Government

be amended to show a change in zone for a portion of properties located at 131 and 150 Tucker

Street from a Light Industrial (I-1) zone to a Lexington Center Business (B-2B) zone, for 9.23 net

(12.73 gross) acres, from a Two-Family Residential (R-2) zone to a Lexington Center Business (B-

2B) zone, for 0.00 net (0.08 gross) acres, and from a Light Industrial (I-1) zone to a Two-Family

Residential (R-2) zone, for 0.00 net (0.13 gross) acres, being more fully described in Exhibit "A"

which is attached hereto and incorporated herein by reference.

Section 2 - That the Lexington-Fayette Urban County Planning Commission is directed to

show the amendment on the official zone map atlas and to make reference to the number of this

Ordinance.

Section 3 - That this Ordinance shall become effective on the date of its passage.
