BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Division of Water Quality, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to purchase Supervisory Control and Data Acquisition (SCADA) Citect/Historian Support Services for the Town Branch and West Hickman Waste Water Treatment Plants and pump stations from Advantage Industrial Automation, Inc., a sole source provider; and that the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute any necessary agreement with Advantage Industrial Automation, Inc., related to the procurement.

Section 2 - That an amount, not to exceed the sum of \$35,145.00, be and hereby is approved for payment to Advantage Industrial Automation, Inc., from account # 4002-303401-3401-76102, pursuant to the terms of the purchase requisition.
