WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$450.00 for the Division of Traffic Engineering from Neighborhood Development Funds for the installation of one speed table on DePorres Avenue:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount of \$450.00 for the Division of Traffic Engineering from Neighborhood Development Funds for the installation of one speed table on DePorres Avenue and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
