WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for the Division of Police for funds in the amount of \$800.00 from Neighborhood Development Funds to assist with the D.A.R.E. program:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for the Division of Police for funds in the amount of \$800.00 from Neighborhood Development Funds to
