WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for funds in the amount of \$32,000 in the Division of Facilities and Fleet Management from the Council Projects Funds for the purchase of a truck for Streets and Roads:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the amount of \$32,000 in the Division of Facilities and Fleet Management from the Council Projects Funds for the purchase of a truck for Streets and Roads and that to effect such Amendments the following appropriations be

Section 3 - That this Ordinance shall become effective on the date of its passage.
